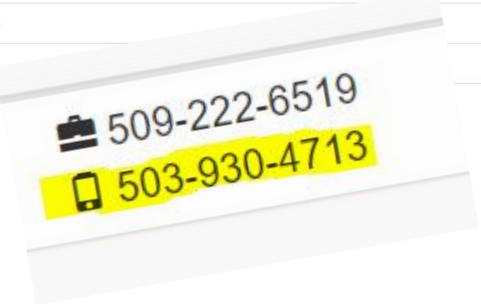

18.25.2 In order to maintain amateur standing, *"the student-athlete may not: D. Play on an intercollegiate team. A student athlete may try out and/or participate against an intercollegiate team but may not represent an intercollegiate team in that sport."*

There is the difference between "**participating against**" (which is common in individual sports and during non-school team sport contests) and "**representing**" a team and university club sports count as intercollegiate teams.
